### SAILING INSTRUCTIONS

The notation '[NP]' in a rule of the Sailing Instructions (SIs) means that a boat may not protest another boat for breaking that rule. This changes RRS 60.1(a).

#### 1 RULES

- 1.1 The regatta will be governed by the rules as defined in *The Racing Rules of Sailing* 2021-2024 (RSS) applicable from 1 January 2021.
- 1.2 Australian Sailing (AS) Special Regulations Part 2 for off-the-beach classes.
- 1.3 The Taipan Catamaran Association Championship Rules, except as may be amended by these Sailing Instructions, which take precedence.
- 1.4 The Class Rules of the Taipan 4.9 & 5.7 Catamarans, except as may be amended by these Sailing Instructions, which take precedence.
- 1.5 Arbitration will be conducted in accordance with Appendix T of the RRS.
- 1.6 Regatta Entrants are not permitted to directly represent the TCAA in matters relating to Race Management, where there may be a conflict of interest, whether actual or perceived.

#### 2 NOTICES TO COMPETITORS

- 2.1 Notices to competitors will be posted on the "2023 Taipan Cat National Championships" regatta page of the "Sailor" App.
- 2.2 Notices to competitors including changes to Sailing Instructions will also be posted on the Official Regatta Notice Board located on the upper deck opposite the race control tower and the "2023 Taipan Cat National Championships" regatta page in the Sailor app.

#### **3 CHANGES TO SAILING INSTRUCTIONS**

Any change to the Sailing Instructions will be posted on the Official Regatta Notice Board and the "2023 Taipan Catamaran National Championships" regatta page in the Sailor app no later than 09:00 hours on the day it takes effect, except that any change to the schedule of races will be posted by 2000hrs on the day before it will take effect. Refer TCAA Championship Rules 6.3

#### 4 SIGNALS MADE ASHORE

- 4.1 Signals made ashore will be displayed on the club flagstaff.
- 4.2 When flag AP is displayed ashore, '1 minute' is replaced with 'not less than 30 minutes' in the race signal AP.

- 5.2 Code flag "L" will be flown on the finish boat to indicate that another race will be started following completion of the current race. If code flag "L" is not displayed on the finish boat at the finish of any race, that race session is concluded.
- 5.3 To alert boats that a race or sequence of races will begin soon, the orange starting line flag will be displayed with one sound at least five minutes before a warning signal is made.
- 5.4 On the last day of the regatta no warning signal will be made after 1500hrs.
- 5.5 A maximum of 10 races shall be sailed.
- 5.6 There shall be no more than 3 races sailed back-to-back in any one Race Session, unless required on the final day to constitute a series. There may be more than one Race Session per Race Day, which shall be advised at the Briefing.
- 5.7 The Race Committee, in consultation with the TCAA Organising Committee, may utilise the scheduled Lay Day on 6/1/2023 in order to make up a shortfall in races completed or to anticipate an inability to race on 7/1/2023 based on weather forecasts.

#### 6 DIVISIONS & DIVISIONAL FLAGS

6.1 <u>Divisions</u>

Division 1 – Taipan 4.9 Cat Division 2 – Taipan 4.9 Sloop Division 3 – Taipan 5.7/5.7 Spin





6.2 Divisional Flags

Division 1 – Numeral Pennant 1 Division 2 – Numeral Pennant 2 Division 3 – Numeral Pennant 3

#### 7 RACING AREA

- 7.1 The racing area shall be on the waters of Port Phillip in the vicinity of the McCrae Yacht Club.
- 7.2 [NP] Boats shall not enter the 'No Boating Zone' as shown in Appendix B during racing. Failure to comply will result in a boat being scored DSQ for the race or races without a hearing. This changes rules 63.1 and A5.

#### 8 THE COURSES

- 8.1 The Taipan Catamaran Championship Course is shown at Appendix "A", including the side on which each mark is to be left.
- 8.2 Legs of the course shall not be changed after the preparatory signal. This changes Rule 33.
- 8.3 No later than the warning signal, the race committee may display the approximate compass bearing of the first leg.

#### 9 MARK ROUNDINGS

Start – 1, 1a, 2s/2p – 1,1a, 2s/2p – 1,1a, 3 – Finish

#### 10 MARKS

Marks 1, 2s and 2p will be large pink inflatable buoys Mark 1a will be a thin cylindrical blue inflatable buoy Mark 3 will be a large orange inflatable buoy Mark A will be an orange stick mark with an orange flag Mark B will be an orange stick mark with a blue flag

#### 11 THE START

11.1 Races will be started as follows:

| Signal      | Flag and Sound                         | Minutes |
|-------------|--|---------|
| Warning     | Division flag; 1 sound                 | 3       |
| Preparatory | P, U, I, Z or black flag; 1 sound      | 2       |
| One Minute  | Preparatory flag removed; 1 long sound | 1       |
| Start       | Division flag removed; 1 sound         | 0       |





This changes RRS 26

- 11.2 The starting line will be between a staff displaying an orange flag on a Race Committee Vessel at the starboard end and Mark A.
- 11.3 [NP] Boats whose warning signal has not been made shall avoid the starting area during the starting sequence for other races.
- 11.4 [NP] A boat starting later than 5 minutes after her starting signal will be scored Did Not Start (DNS) without a hearing. This changes rules A4 and A5.
- 11.5 Rule 29.2 is amended to state that the warning signal for the first recalled Division will be displayed at the start of the last Division, except when there are no other divisions to start. The warning signal of subsequently recalled Divisions will be displayed at the start of the preceding recalled Division.

#### 12 THE FINISH

- 12.1 The finishing line will be between a mast displaying a blue flag on the race committee vessel and Mark B.
- 12.2 A boat having finished her race shall not interfere with boats that are still racing and shall keep clear of the course side of the finish line. Only the PRO may lodge a protest under 13.2. This changes RRS 60.1.

#### 13 PENALTY SYSTEM

Rule 44.1 is changed so that the Two-Turns Penalty is replaced by a One-Turn Penalty.

#### 14 TIME LIMIT

- 14.1 The time limit for the first boat to complete the course in each Division is 90 minutes.
- 14.2 [NP] Boats failing to finish within 30 minutes after the first boat in her division sails the course and finishes, or up to 90 minutes from her start signal, whichever is the longer, shall be scored Did Not Finish (DNF) without a hearing. This changes RRS 35, A4 and A5.

#### 15 SHORTEN COURSE

- 15.1 Courses shall only be shortened at Mark 2, where Code Flag "S" shall be displayed attached to or adjacent to the mark. All boats shall then proceed to the Finish via Mark 3, as defined in the Course description/diagram, taking Mark 3 to port.
- 15.2 The Course shall not be shortened unless the "gate" has been traversed at least once by a boat from any division.





#### 16 PROTESTS AND REQUESTS FOR REDRESS

- 16.1 Protest forms are available at the race office, located on the upper deck. Protests and requests for redress or reopening shall be delivered there within the protest time limit.
- 16.2 For each Division, the protest time limit is 60 minutes after the last boat has finished the last race of the day or the race committee signals no more racing today, whichever is later.
- 16.3 Notices will be posted no later than 30 minutes after the protest time limit to inform competitors of hearings in which they are parties or named as witnesses. Hearings will be held in the protest room, located at the rear of the race control tower, beginning at the time posted.
- 16.4 Notices of protests by the race committee or protest committee will be posted to inform boats under rule 61.1(b).
- 16.5 [NP] Breaches of instructions 18, 19, 20, 21, 22 and 23 shall not be grounds for a protest by a boat. This changes rule 60.1(a). Penalties for these breaches may be less than disqualification if the protest committee so decides. The scoring abbreviation for a discretionary penalty imposed under these instructions will be DPI.
- 16.6 On the last scheduled day of racing a request for reopening a hearing shall be delivered:
  - (a) within the protest time limit if the requesting party was informed of the decision on the previous day; and/or
  - (b) no later than 30 minutes after the requesting party was informed of the decision on that day.

This changes rule 66.

- 16.7 On the last scheduled day of racing a request for redress based on a protest committee decision shall be delivered no later than 30 minutes after the decision was posted. This changes rule 62.2.
- 16.8 Protest mediation may be used as a preliminary step prior to a full protest hearing for protests under the rules of Part 2 and 4. If a boat accepts a penalty during a mediation hearing, the penalty shall be half the points the boat would have lost had the boat been disqualified in a full protest hearing.

#### 17 SCORING

- 17.1 The "Low- Point" scoring system, Appendix A of the RRS will apply.
- 17.2 Four races must be completed to constitute a Championship series.
  - (a) When fewer than five races have been completed, a boat's series score will be the total of all her race scores.
  - (b) When five to eight races have been completed, a boat's series score will be the total of all her race scores excluding her worst score.
  - (c) When nine or more races are completed, a boat's series score is the total of her race scores, excluding her two (2) worst scores.





#### 18 [NP] SAFETY REGULATIONS

- 18.1 Sign On and Sign Off: All boats must "sign on" before leaving the shore and "sign off" as soon as practicable after returning to shore at the completion of the session's racing.
- 18.2 The Sign On period for each Division will close at the scheduled warning signal time of the first race for that session on that day. Competitors who wish to sign on for subsequent races in that session must advise the Regatta Office.
- 18.3 The Sign Off period for each Division will close 60 minutes after the last boat has completed the last race of the session, or the race committee signals no more racing today, whichever is later.
- 18.4 Each skipper shall Sign On and Sign Off using the relevant function within the Sailor app. Traditional hardcopy pen/paper is not available.
- 18.5 A boat's regatta registration will constitute her Sign On for the first session.
- 18.6 In respect to 18.2, a boat may approach the Race Committee Vessel, prior to the raising of the Warning Signal for the first division of the Race Session, and "verbally" Sign-on". This dispensation shall only apply once to each entrant over the period of the regatta.
- 18.7 Failure to Sign On or Sign Off in accordance with Sailing Instruction 16.1 will result in that boat being scored DSQ for all races of the relevant session without a hearing.

This changes rules 63.1, A4 and A5.

18.8 Races shall NOT START where the average wind strength over the previous 10 mins exceeds 22 knots, or is less than 4 knots.

#### 19 [NP] REPLACEMENT OF CREW OR EQUIPMENT

- 19.1 Substitution of competitors will not be allowed without prior written approval of the Race Committee in consultation with the TCAA Organising Committee (refer Championship Rule 3). Requests for substitution shall be made to the Race Committee in writing at the first reasonable opportunity.
- 19.2 Substitution of damaged or lost equipment will not be permitted unless authorised by the Race Committee and TCAA Chief Measurer, or approved delegate. Requests for substitution shall be made at the first reasonable opportunity (refer Championship Rules 4.7).

#### 20 [NP] EQUIPMENT AND MEASUREMENT CHECKS

A boat or equipment may be inspected at any time by the TCAA Chief Measurer, or a delegate approved by the TCAA Organising Committee and the PRO.

#### 21 [NP] OFFICIAL BOATS

Official boats will be marked by the McCrae Yacht Club burgee or name.





#### 22 [NP] SUPPORT BOATS

Team leaders, coaches and other support personnel shall stay outside areas where boats are racing from the time of the preparatory signal for the first Division to start until all boats have finished or retired or the race committee signals a postponement, general recall or abandonment.

#### 23 [NP] RADIO COMMUNICATION

Except in an emergency, a boat shall neither make radio transmissions while racing nor receive radio communications not available to all boats. This restriction also applies to mobile telephones.

#### 24 PRIZES

24.1 Prizes shall be awarded for each Division as follows:

- (a) 3 or fewer boats: 1st place
- (b) 4 to 6 boats: 1st and 2nd place
- (c) 7 or more boats: 1st, 2nd and 3rd place
- 24.2 Further prizes may be awarded at the discretion of the TCAA Organising Committee.

#### 25 EVENT ADVERTISING

- 25.1 If required, boats shall display event advertising supplied by the event sponsor such that the event advertising stickers are located on outer starboard and port sides of the hulls within 25% their lengths (approx. 1.35 meters) from the foremost point of the hulls
- 25.2 Such advertising stickers shall remain in place for the duration of the regatta.

#### 26 DISCLAIMER OF LIABILITY

Competitors participate in the regatta entirely at their own risk. See Rule 3, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

#### 27 INSURANCE


Each participating boat shall be insured with valid third-party liability insurance with a minimum cover of \$5,000,000.00 (recommended \$10,000,000.00) per incident or the equivalent. Competitors may be required to produce evidence of such insurance and any competitor not holding this cover shall withdraw their entry.
